## NEW BUSINESS:

Diana Valentine 19 East 18<sup>th</sup> Street Huntington St., NY 11746 613-549-3713 requests permission to donate a tree in memory of her friend Janet Briggs who is buried on Section 14 Lot 492 (right behind Dolan on the corner). They would like a flowering tree such as a redbud, dogwood or something similar. Her email is attached. Shawn will have final say on the species of the tree. Motion made – 2<sup>nd</sup> – carries.

Irene Georgakoudi would like to donate a tree and a bench in memory of her ex-husband (buried elsewhere). We intend to ask for a donation to per-care for the care and replacement of the tree & bench as necessary. All expenses will be paid by her. She would like the work to be done by June 21,2010, we may ask her to hire a contractor to do the work in order to meet that deadline. She is considering a teak or metal bench and Aspen (mature height of 40-50 feet), location to be determined. I would like to remove one of our under-performing shrub gardens and put this memorial in it's place. Potential location is southwest corner of section 7 four grave lots in Woodlawn. Location approved, teak bench approved. Motion made to accept the donation thus far to be re-visited with details, 2<sup>nd</sup>, motion carries.

We would like to paint the veterans flag pole black this year, copy of photo attached. Motion made, 2<sup>nd</sup>, carries.

We would like to commission Colmer Monument to clean the Raymond monument out of it's trust fund money; the cost would be approx \$250.00 7414-570000. Motion made, 2<sup>nd</sup>, motion carries.

Tom Tidman updated the Commissioners on Morrison Farm, the new backhoe status, and Shawn's truck replacement status.


