7:35 Status update on Consent Order for 41 Esterbrook Road, DEP #85-403

Brian Butler, from Oxbow Associates, discussed the site walk which had occurred on May 14th with Commission members. He delivered a short presentation depicting the status of the site and requested relief from the existing Order.

Mr. Jobs, lawyer for Kim Sieurin, noted that anything in a written form must also be in a recordable form, that is, it must be notarized and reference the recorded

CO. Mr. Jobs will draft a form for Acton Town Counsel to review, and which will then be signed by the Commission.

Mr. Butler noted that the restoration has now been in place and monitored by his firm for four (4) years. He is pleased with the success of the three ponds and surrounding meadows. He suggested that the Commission allow for yearly mowing of the meadow to prevent trees from becoming established.

Decision: Mr. Maitland moved that the Administrative Consent Order has been satisfactorily completed and, once the language has been approved by Town Counsel, the Commission will officially approve. Ms. Green seconded the motion and it passed unanimously.
