Ms. Portante moved that the Commission issue a Certificate for 18 Alcott Street; Mr. Arnold 2nd, unanimous.

Mr. Colman moved that the Commission approve the minutes for December 5, December 19, 2012 and January 2, 2013; Mr. Froberg 2nd, unanimous.

Review - Residences at Quail Ridge Country Club - Conservation Restriction (030)

Tom Arnold, Jim Colman, Tom Tidman and Roland Bartl met today to discuss the Conservation Restriction (CR) at Quail Ridge Country Club. There are outstanding issues that need to be resolved in the draft of the CR. One example is page 3, section B1, regarding acts and uses allowed on the property. The language is ambiguous, allows some commercial activity and some permanent structures. It was written by Pulte's attorney and it was approved by Acton town counsel. The CR would be "held" by the Commission.

Mr. Colman stated that there have been CR's on golf courses in the past. Tom Arnold recommends that any decisions be postponed.

Bettina will email the draft of the CR to the Commission.

Ms. Portante asked if the purpose of the CR is to keep it from becoming a development; and the reply was yes.

Mr. Maitland would like to see a plot plan and some other examples of CR's on golf courses; and he recommends checking with the MACC for guidance.

7:50 Review - Hybrid Farm (040-043)

The Commission discussed Wick McConnon's site plan, specifically the location of fences delineating town property from Hybrid's private property.

Mr. Colman suggested an information kiosk of some sort with a map, to educate the public about the layout of the land.

Tom Arnold said having a public access gate on the private property portion doesn't make sense. It makes more sense to have public access from public side of the property. A gate is required by law to provide public access to the conservation land.

Wick McConnon proposed moving one of the gates on his site plan to another spot. The consensus was that it's merely a compliance issue, not for practicality. Try it for a year see how it goes.

Mr. Colman asked Mr. McConnon about the future of Area D. Wick and Rita will discuss this and decide if more trees should get taken out. It does not have to remain forested, but has grown a lot in the past 25 years.

Stormwater will be discussed spring/summer at 2014 renewal.

Mr. McConnon asked if the Wetland Protection Act agricultural exemption would negate the need for stormwater mitigation. Mr. Colman suggested that the Commission needs to be sure runoff won't damage vernal pools.

MOTION: Tom Arnold moves we approve renewal of License January 15, 2013 for one year; and also approve relocation of fences as shown on the 1/7/2013 site plan on file in the Town of Acton "O" Drive; the adequacy of the surety bond is pending town counsel review; and a letter should be sent to the McConnons' regarding approval of the fence location.

Mr. Colman seconded the motion.

Discussion:

Bill Froberg asked if the Commission will need to vote on all changes going forward each year.


Fran Portante stated she did not think it likely that they would be going through this each year. The Commission discussed how much detail might be needed to review annually.

Jim Colman stated the procedure should be followed strictly now, then amended in subsequent years.

All were in favor of the motion, the vote passed unanimously.


A site walk will occur sometime at the end of March to review status on the ground with regard to the checklist.
