# Update on Kelley's Corner Improvement Selection Committee

Larry Kenah presented a brief update on the Selection Committee appointed by the town manager to review proposals related to the Kelley's Corner Improvement Initiative. The update summary is attached to these minutes.

The committee will be interviewing candidates in the first two weeks in November and passing their recommendations along to the Town Manager shortly after that.

# **Additional Town Personnel Request**

Roland Bartl, Planning Director, asked the EDC for its support for a personnel request to help support the Town's historic preservation and economic development functions". In the discussion that followed, the committee wondered how the position would be used with respect to economic development and, in particular, how the person filling the position would be measured. The committee, through the chair, sent a reply to Mr Bartl asking these questions.

# More on Economic Development and Related Matters

In a follow-up discussion, Dave Clough reported that there are currently no zoning articles proposed for either Fall 2013 or Spring 2014. In particular, zoning articles aimed at Kelley's Corner are not likely to appear before Spring 2015.

He also provided the latest on the CVS plans, a meeting with the abutters to explore their concerns. As a result of that meeting, the developer agreed to install a fence between the CVS development and the Beverly Road neighborhood to discourage shoppers from using that neighborhood as an alternate parking area.
