## Committee discussion on parking lot/ Mr. Richard's property

Meeting date: 12/18/2014

- Tom Campbell and Sean Hanley surveyed the Richard's property and drew up a concept document that would retain the main building (for other usages such as EMT Vehicle rental), office space, food pantry etc...
- By removing the small garage for an entrance, a rough estimate of 110 130 car spots could be placed there for revenue (4.00 would yield roughly \$140K per year)
- Parking would have the least impact on the neighborhood,
- The wetlands across the street Stow at Maple would need to be planned and work through,
- Trey's comment is that he would like to keep South Acton a "walkable village" and to keep the options open.
- Claire's comment was to keep a South Acton Village but this plan will impact Martin Street.
- AT this time, the discussion ended and a motion was taken to put this on the next meeting's agenda for more discussion.

## Additional comment regarding Mr. Richard's property

There was some discussion that apartments could be placed there (or a 40B development) with a many as 90 units. This was met with dissatisfaction with the neighbors in attendance.
