## TOWN MANAGER'S UPDATE

### ANNUAL BUDGET PRESENTATIONS

On December 16th, I presented the Fiscal Year 2026 - 2035 Capital Improvement Plan to the Select Board. This capital plan identifies long-term needs and investment priorities to inform the work that goes into developing the annual operating budget. Some highlights included in this year's plan is the final design and construction of a new DPW Building (pg. 8); Town Hall Electrification (pg. 13); Complete Streets and Sidewalk program (pg. 15); and several projects aimed at sustainability, equity, infrastructure maintenance and repairs, and communication. Capital Improvement Plan


As the Select Board and Finance Committee reviews and provides additional feedback, the FY26 capital plan will continue to evolve.

### DPW BUILDING DESIGN PROGRESS AND UPCOMING MEETINGS

During the December 12th DPW Building Committee, project designer Weston & Sampson provided an update on design, cost estimates and value engineering efforts to date. The Committee reviewed options for value engineering and ultimately decided on eliminating a number of items included in design. These reductions resulted in a savings of over \$4M, reducing the estimated project cost to \$43M. Value engineering efforts continue with the goal of further reducing the overall estimated project costs. ## **WINTER HAS ARRIVED!**

The DPW offers the Following Information/Reminders

### **WINTER PARKING BAN**

Residents are reminded that a winter parking ban is in effect from November 1 until April 1. On-street parking is not allowed between the hours of 1:00 a.m. and 6:00 a.m. The parking ban also includes the Municipal Parking areas located behind the W. Acton Fire Station (258 Central St), S. Acton Fire Station (54 School St), Railroad Street, rail trail terminus at Maple Street, and at the end of Sylvia Street. Your cooperation is greatly appreciated.



### **WINTER MAINTENANCE**

Please remember that our crews have to travel on snow covered, slippery untreated roads to get here at any hour of the day or night. Please be patient as the crews will be out as soon as possible to begin the snow & ice operations.

### **FIRE HYDRANTS**

Fire hydrants are under the control of the Acton Water District. The Water District asks residents with hydrants in front of or near their property to please clear the snow away from the area so that in an emergency the hydrant will be accessible. Questions regarding snow removal near hydrants should be directed to the Acton Water District at (978) 263-9107.

### **SIDEWALKS**

Normally, sidewalks are plowed during the storm and scraped in the following days if needed. Sidewalks in the school zones are given first priority. We ask that you do not block sidewalks with snow shoveled or plowed from your driveway.

### **MAILBOXES**

Mailboxes installed in the Town right of way are placed at the owner's risk. Each mailbox installation should be sufficiently solid to withstand snow-clearing efforts by the Town. It is the responsibility of the owner of the mailbox to clear the snow around the mailbox to assure mail delivery by the U.S. Postal Service, not the DPW or its plow contractors. If the snow banks are too high to shovel, place a temporary box beside the road until the snow has melted enough to allow access to the mailbox. Please check that your mailbox and post are secure and in good condition prior to the snow season. When installing a mailbox choose a suitable location. If you are unsure, check with the postal carrier.

### **BASKETBALL POSTS & NETS**

Please remove your basketball posts & nets away from the edge of the road before the snow & ice events. These can cause damage to Town vehicles and also interferes with snow removal operations. The Town cannot be held responsible for damage caused to them.

### **Wed, January 29 - “Dreadful Were the Vestiges of War: Bullet Strikes from the First Day of the American Revolution” with Joel Bohy**

Acton Town Hall, Room 204 at 7 PM



In 2015, Joel Bohy began a collaboration with conflict archaeologist Dr. Douglas Scott to understand more about the objects that were turning up during archaeological investigations on former battlegrounds. They studied all the surviving bullet-strikes including Buckman Tavern in Lexington, whose front door still bears the mark of a bullet fired on April 19, 1775. They also studied a powder horn worn by James Hayward of Acton who was shot through this horn at Fiske Hill during the British retreat. As Lord Percy arrived and led the British back to Boston, the Jason Russell House in Arlington was the scene of intense fighting. Using modern forensic techniques, Bohy and Scott have been able to determine what types of arms were used.

### **Wed, February 26 at 7 PM - Acton Patriots of Color Theme**

Please join our celebrated historians Bob Pion, Bill Klauer and Anne Forbes discussing the most recent learnings of Acton's Black residents, in honor African-American History Month. Black citizens were among the residents here when first became a Town in 1735 and several fought in the Revolution at the Concord Bridge and other New England battles.

### **March 6, 2025 at 7 PM – Presenter: Meredith Bergmann**

**Acton Town Hall, Room 204.**

Meredith Bergmann designed the Phillis Wheatley Monument, which was installed in 2003. The monument is made of bronze and granite and measures 59 in x 50 in x 32 in. Phillis Wheatley is considered the first African-American author of a published book of poetry.

### **March 22, 2025 at 1 PM - South Acton Tour with Amy Cole**
